

EXTENSION OF AUTHORISATION FOR A MINOR USE OF A PLANT PROTECTION PRODUCT

The circumstances in which this Extension of authorisation will be withdrawn or amended are set out in Regulation (EC) No 1107/2009.

This extension of authorisation for minor uses applies to all authorised parallel trade products issued under Article 52 of Regulation (EC) No 1107/2009 for which Starane XL with MAPP 19775 is the reference product.

ADVISORY INFORMATION

IMPORTANT: When applying this product under the terms of this Extension of authorisation, comply with any resistance guidance or restrictions stated on the product label.

Total reliance on one pesticide will hasten the development of resistance. Pesticides of different chemical types or alternative control measures should be included in the planned programme. Alternating with different modes of action is a recognised anti-resistance strategy.

Use only as part of a resistance management strategy that includes cultural methods of control and does not use ALS inhibitors as the sole chemical methods of control.

A strategy for preventing and managing such resistance should be adopted. Further guidance on weed resistance management is available from the Herbicide Resistance Action Committee (HRAC) and the Weed Resistance Action Group (WRAG). Guidelines are available from WRAG.

Avoid breathing vapours or spray.

Use only outdoors or in a well-ventilated area.

The maximum size of Christmas trees and forest nursery must not exceed 50cm in height.

This Extension of Authorisation relates to the use of 'Starane XL' for the control of Broad leaved weeds (*Polygonum Weeds*) including Cleavers, Brassicas, Mayweed, Groundsel and Volunteer oilseed rape on outdoor and protected field-grown Hardy Nursery Stock (HNS) and non-bulb cut flowers, bulb cut flower production (including rhizomes, corms and tubers), and forest nursery and Christmas Trees to 80-250 litres water per hectare.

APPENDIX 1: CONDITIONS OF EXTENSION OF AUTHORISATION

The conditions below are obligatory. They must be complied with when the Extension of authorisation occurs. Failure to comply with the following conditions will result in the withdrawal or amendment of the Extension of authorisation under Regulation (EC) No 1107/2009 and may result in other enforcement action, including prosecution. For the purposes of this Extension of authorisation only, the conditions and/or requirements shown below supersede any corresponding conditions and/or requirements set out on the label or otherwise provided for under the product authorisation **which would otherwise apply**.

Operator Protection:

- (1) Engineering control of operator exposure must be used where reasonably practicable in addition to the following personal protective equipment:

Operators must wear suitable protective clothing (coveralls), suitable protective gloves and face protection (faceshield) when handling the concentrate.

- (2) However, engineering controls may replace personal protective equipment if a COSHH assessment shows that they provide an equal or higher standard of protection.

Environmental protection:

- (1) Crops/situations with 5m buffer zone:

Since there is a risk to aquatic life from use, users not applying the statutory buffer zone must either themselves carry out or ensure that someone else has carried out a Local Environment Risk Assessment for Pesticides (LERAP) on their behalf before each spraying operation from a horizontal boom sprayer. Users must not allow direct spray from horizontal boom sprayers to fall within 5m of the top of the bank of any static or flowing waterbody or within 1m of a ditch which is dry at the time of application (these distances to be measured as set out in the guidance documents available from HSE Chemical Regulation Division's website and any amendments that are made to it) unless:

(a) The LERAP indicates that a narrower buffer zone will be sufficient; and

(b) Any measures indicated by the LERAP as justifying the narrower buffer zone are complied with in full and in accordance with any conditions applicable to them.

Spray must be aimed away from water.

Spray from hand-held sprayers must not be allowed to fall within 1m of the top of the bank of a static or flowing waterbody. Spray must be aimed away from water.

- (2) The results of the LERAP must be recorded in written form and must be available for a period of three years for inspection to any person entitled to exercise enforcement powers under or in connection with the Plant Protection Products Regulations 2011 or the Plant Protection Products (Sustainable Use) Regulations 2012. (An electronic record will satisfy the requirement for a written record, providing it is similarly available for inspection and can be copied).

- (3) Detailed guidance on LERAPs and how to conduct a LERAP are contained in the guidance documents available from HSE Chemicals Regulation Division's website. All LERAPs must be carried out in accordance with this Guidance and any amendments that are made to it.
- (4) Extreme care must be taken to avoid spray drift on to non-crop plants outside of the target area.

Other specific restrictions:

- (1) This product must only be applied in accordance with the terms of this extension of authorisation, the product label and/or leaflet and any additional guidance on extensions of authorisation.
- (2) When used in ornamental plants, the seed or any part of treated plants must not be used for human or animal food or feed.
- (3) Applications to crops made between 1st September and 31st December can be made up to a maximum individual dose of 1.5 L/ha. A split application may be applied up to a maximum total dose of 1.5 L/ha where weed germination takes place over an extended period.
- (4) The maximum total dose of florasulam applied to the crop must not exceed 7.5g per year. Only one application must be made to a crop between September and February 1st.

APPENDIX 2: GENERAL CONDITIONS FOR AN EXTENSION OF AUTHORISATION

Failure to comply with the following conditions will result in the withdrawal or amendment of the Extension of authorisation under Regulation (EC) No 1107/2009 and may result in other enforcement action, including prosecution.

Adverse effects:

The authorisation holder must immediately notify the Secretary of State, the Welsh Ministers, the Scottish Ministers and the Department of Agriculture, Environment and Rural Affairs in Northern Ireland (care of the Health and Safety Executive), if they have any new information on the potentially adverse effects of the authorised product, or of residues of an active substance in that product when used in accordance with the conditions of this authorisation. For those products authorised under Regulation (EC) No 1107/2009 as it has effect by virtue of the Protocol on Ireland/Northern Ireland in the EU withdrawal agreement, authorisation holders must also tell the other relevant competent authorities of the EC Member States (a list of which is available from the Health and Safety Executive) and the EC Commission. Failure to comply with this requirement is an offence.

Provision of information:

The authorisation holder must comply with all requests for information required by, or on behalf of, the Secretary of State, the Welsh Ministers, the Scottish Ministers or the Department of Agriculture, Environment and Rural Affairs in Northern Ireland in accordance with Regulation (EC) No 1107/2009.
